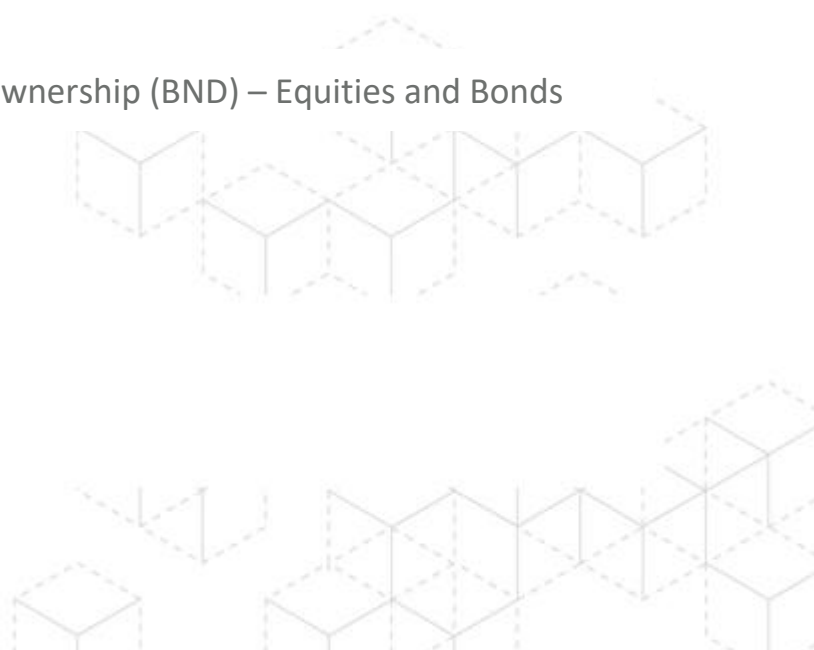


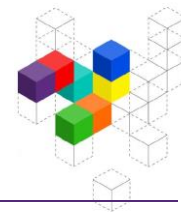

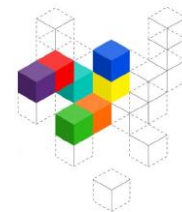

1.1 INTERPRETATIONS AND DEFINITIONS⁴

1.1.1 In this Strate Directive, any interpretation, word, or expression to which a meaning has been assigned in the Strate⁵ Rules bears the meaning so assigned to it.⁶

‘BDA’ means the Broker Deal Accounting system operated by the JSE;

‘BND’ means Beneficiary download, which is the disclosure of information on Beneficiary holdings as prescribed in this Strate Directive;

‘Beneficiary’ means a person holding a beneficial interest in Securities;⁷

‘BIC’ means Bank Identifier Code, which is the SWIFT identifier code of organisations with a SWIFT address;

‘BP’ means business partner;

‘Broker’ means an Authorised User, being a person authorised by an Exchange in terms of the Exchange rules to perform such Securities services as the Exchange rules may permit;

‘C’ means conditional, indicating that the particular information must be provided to Strate for certain account types, or where a related field has been completed;

‘EOD’ means “End of Day” and is the time as stipulated in Strate Directive SC.1 – *Operational Market Windows – On-market – Equities* and Strate Directive SD.1 – *Operational Market Windows – On-market – Bonds*;

‘FSB’ means the Financial Services Board;

‘FTP’ means File Transfer Protocol;

‘Holding Date’ means the date on which the record of Beneficiary holdings must be ascertained;

‘Id’ means identifier;

‘ISIN’ means International Securities Identification Number, a unique internationally recognised securities identification number;

‘JSE’ means the JSE Limited Registration Number 2005/022939/06;

‘M’ means mandatory, indicating that the particular information must be provided to Strate;

‘Naming Standards’ means the standardised naming conventions incorporated in this Strate Directive for the purpose of completing the required BND fields;⁸

‘O’ means optional, indicating that the particular information may be provided to Strate;

‘SCA’ means Safe Custody Account, which is the Central Securities Account;

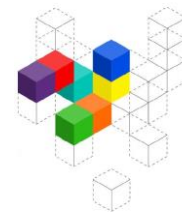

‘Secure’ means to ensure the integrity and confidentiality of the information by taking appropriate reasonable technical and organisational measures to prevent loss of, damage to or unauthorised destruction of the information, and unlawful access to or processing or use of the information; and ⁹

‘SDA’ means Segregated Depository Account as defined in the Strate Rules;¹⁰

‘Strate’ means Strate (Pty) Ltd, Registration Number 1998/022242/07.

- 1.1.2 Strate Directive SA.7 - *Requirements for Nominees to Operate in the Strate Environment* applies in respect of Participant Nominees approved by Strate, as well as the recognition by Strate of FSB approved Nominees, in order to ensure that these Nominees are capable of providing the BND to Strate when required to do so.¹¹

1.2 PROCEDURES¹²

1.2.1 Strate will via E-mail:¹³

1.2.1.1 advise the Participants, the JSE in respect of its Brokers, and Nominees of the Holding Date for the BND; and

1.2.1.2 request the Participants, the JSE in respect of its Brokers, and Nominees to provide Strate with the BND as at the Holding Date.

1.2.2 Participants, Brokers and Nominees must produce their BND files after the processing of their EOD run on Holding Date.

1.2.3 Participants must ensure that their aggregate holdings per ISIN, balances to the holdings in their SCA in the records of Strate.

1.2.4 Nominees must ensure that their aggregate holdings per ISIN balance to the holdings in their Securities Accounts.

1.2.5 The Participants, Brokers and Nominees must send to Strate the BND files via a Secure FTP or other Secure mechanism, by 11H00 on the Business Day following the Holding Date (HD+1).¹⁴

1.2.6 Strate will trigger the BND run once it receives all the files.

1.2.7 The Strate run collates the data received and produces a validation report indicating that the input file has failed validation including details of the row/s in which the error/s occurred. A reconciliation report highlighting the difference per ISIN between the Participant and Strate or between a Nominee or Broker and its Participant will also be produced where applicable.

1.2.8 The Validity and Reconciliation error reports will where applicable be sent by E-mail to the Participants, the JSE in respect of its Brokers, or Nominees.

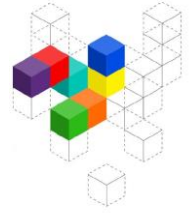

- 1.2.9 Corrected BND files must be sent to Strate via a Secure FTP or other Secure mechanism within 1 (one) hour, unless otherwise agreed to by Strate, of being advised of the error(s).¹⁵
- 1.2.10 The process stipulated in 1.2.7 to 1.2.9 will be repeated if validity and reconciliation errors still exist, until such time as there are no validation errors and an acceptable level of reconciliation has been achieved.
- 1.2.11 The final BND run will be triggered by Strate once all errors are corrected and the files are processed successfully. The Issuer or Transfer Secretary files will be created during the BND run.¹⁶
- 1.2.12 Strate will provide the final BND to the Issuer, its Transfer Secretary or nominated agent.¹⁷

The file layouts shall be used in all instances including those where the Participant and/or Broker has a Client who has been approved as a Nominee in terms of Sections 76(1)(b) and 76(3) of the Act and Strate Directive SA.7 – *Requirements for Nominees to Operate in the Strate Environment*. Participants may use either Participant Layout A or B.¹⁸

2. File Sender Id (Srl No 3)

This is the BP Id at Strate.

3. Registered Account Number (Srl No 17)

This is the account number of the client in the books of the Participant.

4. Beneficiary Account Number (Srl No 18)

This is the client account under the registered account in the books of the Participant or Broker.

5. Client Name (Srl No 19)³¹

Notwithstanding the manner in which the account is recorded in the records of the Participant or Broker, the client's name in the BND must indicate the identity of the Beneficiary. In respect of Own Name clients, the categories referred to in Strate Directive SA.4 – *Requirements for Own Name Clients*, are applicable.

Naming Standards

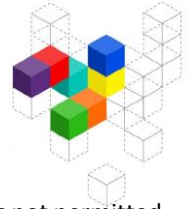
The following Naming Standards are applicable for listed categories of clients:

- Private Individuals – Surname followed by the full first names. A comma must be used between the surname and first names to more easily and correctly identify the name. The BND format is 2*35x and the first names are to follow directly after the comma, in other words the name may wrap into the second line if required. The second line is not to be used specifically for recording the first name/s.
- Account designations such as; “No. 2 A/c” or “Blocked Rand Account” should be recorded by inserting a comma after the first names followed by the account designation.³²
- Trust Accounts – In terms of the Trust Property Control Act, 1988 (Act 57 of 1988), an account or investment at a financial institution must be identifiable as a trust account or trust investment. To accommodate the requirements, the recording of trusts will be as follows – AB Family Trust. To facilitate sorting of shareholders by name “The” will not be recorded, in other words The AB Family Trust must be recorded as AB Family Trust.³³
- Estate Late – Estate Late must be recorded as Estate Late followed by the first names and surname.

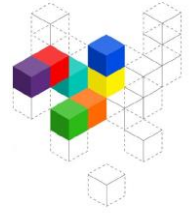

7. Address (Srl No 21 & 22)³⁶

A valid address conforming to accepted postal standards, including a postal code must be provided. If no postal code is available, the field must be populated with four zeroes, i.e. 0000³⁷

NB. The use of any variations of: 'By Hand', 'Do Not Mail', 'Returned Post', 'Internal Mail', 'Fax numbers' or 'Hand to: Mr X' in the address field or an incomplete addresses as well as the use of symbols such as * # ^ etc. or variations of these as part of the address, is not permitted.

8. Email Address (Srl No 23) – Also see the description for Srl No 36 – If the beneficiary requires communication by e-mail this field is mandatory. In other words the field will be populated with the e-mail address of the beneficiary if the mail option selected is 03. NB. In terms of the Companies Act, 2008, Issuers have the responsibility to give notices to, and/or to communicate with their shareholders; and the shareholders have the right to receive notices from the Issuers.³⁸

9. Consolidated Account Owner (Srl No 27) – If the assets of the beneficiary are being administered by an Asset, Investment or Fund manager, the name of the manager administering the fund may be populated in this field. The field is 2*35x.

10. Language Indicator (Srl No 28) – This field reflects the official language of the beneficiary and is optional. The system will eventually allow for 01 to 11 to cater for all the official languages. At this stage it has been agreed that only the following codes will be used.

01 – English

02 – Afrikaans

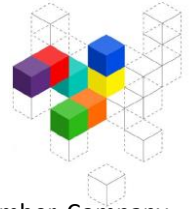
The default code is 01 English.

11. Client Category (Srl No 29) – This is an optional field which will reflect the category of the client e.g. RSA citizen, Emigrant etc. The applicable codes to be supplied are described in the above file layout.

12. Client Identifier (Srl No 30 and 31) – These fields cater for the identification number for example the ID number, Company Registration number etc. The fields are optional and will only be populated if the information is carried by the Participants and Brokers. The way in which the numbers will be recorded is described in the file layout above.

13. Holdings (Srl No 35)

This is the quantity of securities held.

14. Report Indicator (Srl No 36) – This field will determine whether or not the beneficiary requires annual reports, or other Issuer communication, to be sent directly to the shareholder by the Issuer. It also defines the method of communication i.e. mail or e-mail.³⁹
